What accomplishments/progress has your Affiliate made in the past year? (Consider member resources, awards and recognition, public affairs, etc.)

Member Resources

- Kentucky had 136 members in 2024.
- 10 new members were initiated at our November 2024 Annual Meeting.
- Honorary membership was bestowed to Chris Crumrine, UK Senior Director of External Affairs and Engagement.
- Two Friends of KEAFCS honors were presented to outstanding leaders and coworkers for their support of FCS programs.
- Members received two editions of our revised format newsletter to keep them engaged and informed; our association website has been revamped as well.
- Retiree and Life Member meeting held in the summer with around 25 in attendance to receive updates from Extension Administration and NEAFCS.

Professional Improvement

- Three Virtual Town Hall Meeting were held to equip members with new information, build connections, and enhance communication. The first focused on FCS Online Resources with 38 participants; the second focused on National and State Meeting preparations with 58 participants, and the third targeted the state association's Constitution & Bylaws discussion with 37 participants.
- Members had multiple opportunities to engage in discussions related to professional capacity including infographics related to professional attire and image.
- The State President sent handwritten encouragement cards to all members as part of the 90th Anniversary celebration; State FCS Staff participated in a community outreach project for senior citizens in collaboration with agents; numerous members participated in 90th Anniversary activities; our state submitted a creed video entry and made a significant donation to both the hygiene kit project and endowment fund; a podcast was recorded by the State President and National President-Elect to promote our history and impact which was shared at both state and national levels.
- Our state meeting focused on celebrating Kentucky's 100 years. Activities focused on programming changes and similarities, agent sharing, and an overall look at our history and impact.
- A promotional marketing kit was provided to members during our state meeting to celebrate Kentucky's
 100 years and assist agents in monthly messaging during the year ahead.

Awards & Recognition

• A total of 116 award entries were submitted. We were fortunate to have 61 State Winners, 22 Southern Region Winners, and 9 National Winners.

Public Affairs

- Five members attended PILD in April.
- Kentucky created its own impact statement marketing piece to share with elected officials at all levels.
- Our association supported the annual County Judge Executives event along with other professional associations to say thank you for their support and market current initiatives.

Other Special Projects:

 To honor Dean Nancy Cox's retirement, KEAFCS contributed \$500 to the Martin-Gatton College of Food, Agriculture and Environment Scholarship Fund.
